

## Name Change of a minor child in Texas.

Sometimes, people change the name of their child for their protection. Other times, a parent may feel that they made the wrong name choice. A request for name change is most common in divorce suit; a mother may decide that she does not want her child to have the last name of her abusive spouse. The name change must be in the interest of the child.

## Family Law: Termination of Parent's Rights in Texas

The termination of parental rights in Texas.

There are different reasons why a parent's rights may need to be terminated in Texas.

Abuse or neglect.

Abandonment by the parent.

Parent is criminally responsible for the death or serious injury to a child.

When a child in an environment that mentally or physically endangers the child.

Refusal to support the child.

Most Judges are generally hesitant to terminate a parent's rights. However, reasons above are good basis for terminating a parent's rights.

Also, a parent can voluntarily terminate his or her right. This is more common during adoption process.

The steps to changing the name of a minor child is simple, as long as the change is not for criminal reasons or fraudulence.

If the name change is in the divorce petition, the judge will address it in the final divorce decree. However, if the name change is not related to a divorce, the process is different.
